#### 7. PUBLIC HEARING: COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION

County Housing Rehab Community Development Block Grant application. Diana Cvitanovich with the Polk Community Development Corporation read into record the public notice and notice of the public hearing (see permanent record). Diana explained that Polk Community Development Corporation administers and manages the Housing Rehabilitation Program, which is a collaborative of the cities of Monmouth, Dallas, Independence, Falls City and Polk County. Polk County has agreed to be a lead applicant on this biennial grant cycle. The application is for \$400,000 to be used for housing rehabilitation grants for low income households, and hopes to serve 23-25 households with this grant. The Polk CDC also operates a revolving loan fund for low interest housing rehabilitation loans for low to moderate income households.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER POPE SECONDED, TO AUTHORIZE THE SUBMISSION OF THE HOUSING REHABILITATION COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION.

#### 8. TEMPORARY ROAD CLOSURE

Todd Whitaker, Public Works Director, reported that there have been a number of calls received by property owners on Ronco Road expressing concern with fire danger from members of the public in that area. Todd explained that if there were a fire in that area, fire apparatus would not be able to access it because of the weight limits on the access bridge. There are no homes using this road for access, and Todd proposed the road be temporarily closed to the public until the fire danger passes. Todd anticipates that eventually property owners will pursue a vacation or gate permit.

MOTION: COMMISSIONER WHEELER MOVED, COMMISSIONER POPE SECONDED, TO AUTHORIZE THE TEMPORARY CLOSURE OF RONGO ROAD.

MOTION PASSED UNANIMOUSLY.
