 - a. <u>AOC DUES</u> The Board discussed the AOC dues invoice. Craig recommended paying the non-voluntary dues, including the CFTLC dues, and only paying the voluntary Forest Management Sub Committee Dues. The CFTLC dues entities Polk County to continue receiving information.

- b. **BCN BUDGET COMMITTEE** Greg Hansen reminded the Board that the BCN budget committee hearing is scheduled for June 7, 2016. Polk County is in need of a lay member for the budget committee. The Board agreed ask the Polk County Budget Committee to see if anyone would be interested in serving.
- c. <u>COURTHOUSE CHILLER</u> Matt Hawkins, Administrative Officer, informed the Board that the Courthouse Chiller unit is in need of replacing. The County has spent over \$5,000 in repairs over the last few weeks, and the unit requires an additional \$20,000 in repairs to start working properly, or the County can replace the unit for \$100,000. The current unit is approximately 20 years old.
