At 9:00 a.m., Commissioner Wheeler declared the meeting of the Polk County Board of Commissioners to be in session. Commissioner Pope and Commissioner Ainsworth was present.

Commissioner Wheeler recessed the meeting. At 10 am, Commissioner Wheeler called the meeting back into regular session.

8. PUBLIC HEARING

Commissioner Wheeler opened the public hearing regarding County Road Hazards at 9100 Harmony Rd., Sheridan. Todd Whitaker presented a power point presentation. The violations of this road hazard documented by Public Works' staff include, illegal driveway access (violation of PCO § 31.120), road signs visible from the County Road (violation of ORS §368.256), and the roadside concrete block planter (violation of ORS §368.256).

Mr. Whitaker gave an overview of the timeline of events leading to these violations: Public Works sent a letter to the property owner(s), John & Donna Hornsby on June 28, 2016 notifying them of the violations and ordered the hazards abated by July 24, 2016. A response letter was received by the property owner on July 11, 2016 refuting the road hazards. The Hornsby's did not abate the road hazards, and on August 8, 2016, Polk County notices the public hearing due to the continued violations.

Staff explained that Mr. Hornsby attended a court hearing on Monday regarding a code enforcement citation for the operation of an illegal business on the property. The Judge declared the business as illegal and Mr. Hornsby was given two weeks to remove the business. Mr. Hornsby was not in attendance at this hearing. Staff explained that if the Board orders the abatement of the hazards, and Mr. Hornsby does not comply, the Public Works department can then enter the property to abate the hazards at the cost to the landowner.

Mike Moritz, 7305 Emerson Rd., farms property on Harmony Road, andtestified that this summer, he had to re-route all of his trucks to Hwy. 18 to avoid the dangerous conditions caused by the brick planter Mr. Hornsby constructed on the corner of Moritz Road and Harmony Road.

Hans Koennecke, 9095 Harmony Rd., testified that Mr. Honrsby's fence sits 5 feet inside the right-of-way, he then parks trailers along the fence, which greatly impedes the view at the intersection.
