### Polk Extension Service District Notes

January 18, 2023

- 1. Commissioner Pope called meeting to order at 10:00 am
- 2. Comments for items not on agenda

- 3. Approval of Agenda. Commissioner Gordon moved, Commissioner Mordhorst second. Passed unanimously.

#### 5. New Business

North Willamette Research and Extension Center (NWREC) Update - Dr. Surendra Dara, Director

- Commissioner Pope introduced Dr. Dara and stated that he just had his one year anniversary and wanted to say that he is doing a great job.
- Dr. Dara thanked the Board for their support.
- Dr. Dara presented a slideshow to the Board that showed some history of the NWREC center, the counties that are being served, the programs and commodities that are being offered, and some examples of their outreach for this program.
- Commissioner Pope wanted to recognize Alex Paraskevas, SEDCOR, as well as many others for pushing this project and the great work that everyone is doing.
- Commissioner Pope asked where they are at with funding depending on what the
  Legislature does or does not approve. Dr. Dara stated they have recently added 3 new labs
  from donations that were received. Dr. Dara stated to meet their operational needs, they
  could use \$200-\$250k more in funds. Operational costs and maintenance costs are
  constantly increasing.

Extension Administrative Updates – Richard Riggs, Regional Director

Mr. Riggs stated they have some hiring updates, one being Andrea Hunter, who will be
introduced shortly. OSU hopes to have second 4-H faculty in place within a couple of
months, will be an internal search. Hiring for a Small Farms faculty who will serve Lane,
Benton and Polk – this person will take over some leadership of the olive research at
NWREC. SNAP-Ed Education Program Assistant will start in Polk County on Monday.

- Mr. Riggs talked about the OSU Statewides day, which will be on March 21 at the Oregon State Capital. If the Commissioners are interested in attending to speak with legislators about funding for Extension they can let him know.
- Commissioner Pope asked why things are taking so long in getting these positions filled. Mr. Riggs talked about why they are hiring internally and what the hiring process looks like for OSU Extension. Commissioner Mordhorst asked about the application for youth and Master Gardener volunteers and if there was any way to reduce it so it isn't such a long application. Mr. Riggs stated that they can definitely look at those applications. Mrs. Hutchison explained applications for those working with youth are extensive, but once they are an approved leader the renewal process is much shorter.

Introduce new 4-H Faculty, Andrea Hunter – Richard Riggs, Regional Director

- Mr. Riggs introduced Andrea Hunter. Mrs. Hunter provided some background information
  for herself and her involvement with 4-H over the years. Commissioner Pope asked what her
  specialty is and what her focus will be. Mrs. Hunter stated she is very passionate about
  youth leadership development and youth development.
- Commissioner Pope asked for an update on the 4-H center and if it is still open and stay open. Mr. Riggs stated yes it is. Commissioner Pope stated he would like to receive annual updates on the 4-H Center so that they can stay current on what is going on with that center.
- Mrs. Hutchison asked if the Commissioners would be interested in having our next District Meeting at the 4-H Center.
- Commissioner Pope encouraged Mr. Riggs to send any information to the other Commissioners on the legislative changes that are coming.
