Polk County Community Development Department is available to provide flood hazard information for properties located within the unincorporated areas of Polk County. The County maintains a complete set of Federal Emergency Management Agency (FEMA) Flood Insurance Rate Maps (FIRMs), and is available to provide map determinations by phone, in person, or by writing to the County. Information concerning the FIRM zone, map panel number, map date, community number, base flood elevation and floodway are available. One of our most important objectives is to provide the community better sources of information. The Community Development Department, Planning Division continues to ensure the latest information is available on the Polk County Geographic Information System (GIS) Webmaps website, <a href="https://maps.co.polk.or.us/pcmaps/">https://maps.co.polk.or.us/pcmaps/</a>. We cannot accept incomplete or incorrect elevation certificates. We do maintain elevation certificates for new and substantially improved structures in the Special Flood Hazard Area.

In addition to providing valuable floodplain information, we also have a handout available in our office about flood insurance purchase requirements that can provide people with information about purchasing flood insurance if they need a mortgage or loan for a property in a Special Flood Hazard Area.

We can also provide information about wetland areas that may have development restrictions and discuss setback requirements for development activities.
