Summary: This measure re-authorizes Polk County to levy a five (5) year local option tax of up to \$0.425/\$1,000

assessed value beginning in 2019 for the purpose of providing funding to Public Safety (Sheriff-Patrol, Sheriff

-Jail, District Attorney-Prosecution, Juvenile Detention, Court Security and POINT).

Prior to the May 2015 voter approved Public Safety Levy, Polk County's public safety system was suffering from lack of funding and not meeting basic service levels. After approval the County was able to restore 24 hour patrols, reinstate the county-wide drug enforcement team, allow full utilization of community service/work release programs, provide additional court security and juvenile detention beds.

This re-authorization will eliminate the final year of the existing 2015 Public Safety Levy to ensure continuity of service by providing an additional five (5) years of funding, while lowering the levy amount from the current \$0.45/\$1,000 to \$0.425/\$1,000.

The passage of this measure will cost property taxpayers \$85/year on a house assessed at \$200,000 to fund 24 public safety positions.

The estimate tax cost for this measure is an ESTIMATE ONLY based on the best information available from the County Assessor at the time of estimate. The \$0.425/\$1,000 local option tax will generate \$2,720,000 in 2019, \$2,830,000 in 2020, \$2,940,000 in 2021, \$3,060,000 in 2022, and \$3,180,000 in 2023.
