The Fair's bottom line is \$19,968.00.

MANAGER'S REPORT: Maintenance and repairs – Jason reported: the Caretakers sliding glass door has been replaced. The Bingo booth has come down, the Dairy booth is scheduled to come down the first of October. The grounds are being winterized and boat storage is filling up. Tina and Jason are working on a security roll down door for the entry into the Main building.

The Baptism on August 29th had a child running around the yellow curb, he fell and cut his leg open. OFA Meeting re-cap – The OFA meeting went really well, most Fair's in Oregon saw an increase in attendance and revenue, only those with extreme heat had low numbers this year. All Fair's including those with extreme heat saw an increase in Livestock Auction dollars.

The date for the January Convention is the $14^{th} - 16^{th}$ in Salem at the Convention Center. The OFA Convention Committee has been trying to move the dates of the Convention, since Oregon is the last to have their Convention most service members are already booked. They have also been trying to find a more affordable venue. They have finally succeeded, which means in 2016 OFA will have two Conventions, the second will be October $20^{th} - 23^{rd}$ and will be held at the Linn County Fairgrounds.
