

RICKREALL GUN SHOW RULES

1. All Federal, State and Local laws **MUST** be obeyed at all times. **ANYONE** observed in an illegal manner by Show Security or Show Management will be expelled from the show and reported to local authorities.
2. To prevent accidental discharge **NO** loaded firearms are allowed in the gun show, including persons with concealed handgun permit. **Except armed security provided by show management or law enforcement officers**
3. **NO** tables, gun racks, chairs, etc. Are to be placed in aisles, aisles need to be kept free to allow adequate traffic flow.
4. All Gun Show tables must have at least 80% gun or knife related items. No subletting of tables is allowed
5. All transactions are to take place **INSIDE** the gun show building. **NO EXCEPTIONS.**
6. ALL Firearms, old or new must have magazines removed and actions tied open or shut securely, rendering them inoperable. Ties with different colors will be supplied by the show indicating which guns belong to vendors, walk-ins or have been sold. This is necessary to help prevent gun theft. Any firearm found untied will be subject to a \$100.00 fine. Repeat offenders will be expelled from the show
7. Loose cartridges are not allowed near weapons in which they may be used.
8. **ALL** weapons must have magazines removed, where feasible.
9. Knives must be sheathed, unless they are not readily accessible by the public. Glass display cases are recommended to display knives.
10. All lasers and stun devices must have the battery removed or not be readily available to the public
11. All self-defense spray must be in sealed packages.
12. Canvassing or demonstration of exhibit must be confined to the inside boundaries of vendor table space and in no case may extend to any other part of the building or grounds. No flyers may be outside of your rented space.
13. Vendors will be supplied with badges. These must be worn during Friday set up and all of the gun show, these are for those helping at your table only. Misuse of badge **may cause loss of your space at future Rickreall Gun Shows.**
14. 24 hour security is provided from Friday at 6:00pm through Sunday one hour after close, however PCF is not responsible for the loss of any merchandise or personal items by the exhibitor.
15. **NO SMOKING WITHIN THE GUN SHOW BUILDING.** Smoking allowed in posted designated areas only – Patio area on north side of building. **No smoking in front of the building.**
16. No alcohol allowed.
17. Minors under 18 years of age must be accompanied by an adult. Minors under 18 years of age that are with a vendor must wear a name tag at all times.
18. No cameras or Audio/Visual equipment of any kind allowed inside the gun show without permission of Show Management.
19. Show Management and Security reserves the right to inspect any bags, packages or containers entering or exiting the show.
20. Vendors must adhere to vehicle parking guidelines. All RV's must park in designated RV parking areas at the far end of the parking lot and pay overnight parking fee if spending the night. Vendor vehicles must be parked at the south end of the gravel lot, leave asphalt and closer parking to your customers.
21. **NO PETS** allowed in the Gun Show, exceptions may be made for animals that are an integral part of an exhibit space for the purpose of selling an animal related product, Polk County Fair Management must grant such exception in writing. (Seeing Eye guide dogs allowed).
22. Clean up: Due to the recent increase of garbage left behind by vendors, there will be a \$25.00 clean up fee for anyone that doesn't clean up their area at the end of the show. It will need to be paid before you get tables at the next show.
23. **Failure to comply with rules and keep your table space occupied and open for business until the close of the show for the day, without Management approval, or leaving a mess in your vendor space may cause loss of your space at future Rickreall Gun Shows.**
