 (4) Scale and lettering size approved by the County Surveyor so all the information is clear and legible. Lots and parcels are to be numbered consecutively Show bearings and distances for ALL boundaries of every lot/parcel All streets must be named
☐ (5) Show the location and description of all FOUND and SET MONUMENTS The bearings and distances of the exterior boundary must conform with the surveyors certificate.
☐ (6) <u>EASEMENTS:</u> The locations, dimensions and purpose of all recorded and proposed public and private easements shall be shown on the plat. If the easement has been recorded with the clerk then the recording reference must be shown. Private easements become effective when the plat is recorded.
☐ (7) Show the area of each lot/parcel.
□ (8) Show bearings in DEGREES - MINUTES –SECONDS Show distances in FEET and HUNDREDTHS of feet CURVE DATA [on face of map or in a separate table] to include: Arc Length, Chord Length,
☐ Chord Bearing, Radius, and Central Angle.
☐ (11) DO NOT PUT Information that is SUBJECT TO ADMINISTRATIVE CHANGE or VARIANCE by a city or county on the plat.

- (4) The imprint of the official seal of a notary public shall not be required to effectuate a notarization of a subdivision or partition plat required under ORS 92.010 to 92.190 or a condominium plat required under ORS 100.115, or any replat, supplement or amendment thereto, if the following appear below the notary's signature:
 - (a) The printed name of the notary public;
 - (b) The words "NOTARY PUBLIC OREGON";
 - (c) The words "COMMISSION NO." immediately followed by the notary public's commission number; and
 - (d) The words "MY COMMISSION EXPIRES" immediately followed by the date the notary public's commission expires, expressed in terms of the month, by name not abbreviated, two-digit date and complete year.
