PRESENTATION/DISCUSSION

Shop with the Sheriff DEBRIEF: Team discussed the December 11th Shop with the Sheriff event. A total of 23 youth participated and each was matched with a representative from the Polk County Sheriff's Office. A huge thank you to Wal-Mart and Wal-Mart Employees Assn., Spirit Mtn. Casino Employees Sponsorship Program, Confed. Tribes of Grand Ronde, Willamina School District and Grand Ronde Middle School, Grand Ronde Nazarene Church (and other local congregation) volunteers, and of course, the Polk County Sheriff's Office. This year the participating families were given a food box, and the Reading for All Initiative provided new books for youth to take home. Debbie reported she and Rhonda will be meeting with the Sheriff's Office very soon to talk about some ideas for next year's event.

PRESENTATION/DISCUSSION:

Polk County Service Integration Projects and Review (Dave Guile, PCCCF Consultant):

Dave Guile has been working closely with the PCCCF/SI staff for 3-4 months on how to best capture data and report on what is accomplished through Polk County Service Integration. Most of us working in Polk County understand the value of Service Integration. However, relaying what it is we do (to someone not familiar with SI) is often difficult. It is a political reality that some of the Service Integration support comes through tax revenues. Service Integration needs to be made more visible to county and state decision-makers. The ultimate goal for this process is to *increase the visibility of Polk County Service Integration and open up additional grant opportunities (for SI and partnering agencies)*. The information presented included team background and overview, funding and expenditures review, meeting review and reporting, team membership and participating agencies, events and outreach, and collaboration opportunities/outcomes. These reports/documents are still in "draft" form and eventually will be presented as a power-point presentation. Team reviewed recommendations on how to continue what we are doing, while improving how to report and present the value of participating in Service Integration. The team was very excited and positive about the information presented and committed to assisting with the recommendations presented.

Parenting Hub Grant Opportunity (Brent DeMoe, PCCCF): Brent distributed information on a *Parent Education Collaborative Regional Hub Grant* PC Human Service has applied for through the Oregon Community Foundation. The goal is to obtain a grant of approximately \$90,000 per year for three years to create a regional hub matching parent education needs to "Best Practice" parent training programs. He also asked SI partners for letters of support and a commitment to continue a collaborative relationship

with Polk County (through SI teams) in expanding opportunities for parents to access high quality parent education programs. Grant is due February 15th, 2011.
